

d) Defects or damage resulting from fire, flood, accidents, act of God, or any similar cause beyond SDPA's control.

e) Incidental or consequential damages, whether direct or indirect, including but not limited to damages for loss of use or loss of business or profits. Some states do not allow the exclusion or limitation of incidental or consequential damages; so the above limitation or exclusion may not apply.

5. Remedy for Defect. In the event of a defect, malfunction or failure to conform within the scope of this warranty, SDPA undertakes to repair or replace at its option any defective part at no cost to the original consumer purchaser. Nor will the original consumer purchaser be liable for any labor costs incurred in the course of repair or replacement of any defective part during the first thirty (30) days after the date of purchase. After the first thirty (30) day period, however, any such labor charges will be borne by the original consumer purchaser.

6. Procedure for Performance of Warranty Obligation.

a) Bring in or send, post or carriage paid, the bicycle or defective warranted item or part, to any authorized dealer or area distributor, or to SDPA itself, together with the original or a copy of a properly filled-out Part 1 of the Warranty Registration Card, and, if sent, with a written explanation of why the item is being returned.

b) If there is any disagreement about repair or replacement under the Warranty, or if there is any other cause for complaint where the original consumer purchaser had been unable to obtain satisfaction, he or she is cordially invited to contact SDPA directly at its address — P. O. Box 7777, Greenwich, Connecticut 06830 — or telephone — (203) 661-0864, and/or send, post or carriage paid, the bicycle or defective warranted item or part directly to SDPA, in the manner described in the foregoing paragraph.

c) The initial request for repair or replacement must be made not later than thirty (30) days after the expiration of the warranty period.

d) If the bicycle or any part thereof is returned for any cause not covered by this warranty, a charge will be made for testing, handling, packing, return post or carriage, and/or any repairs made.

e) SDPA accepts no responsibility for any damage that occurs to the bicycle or part during transit to or from the original consumer purchaser.

7. No Oral Variation of Terms. No dealer or other person has any authority to orally vary the terms, conditions or exclusions of this warranty or make any representations or express warranties other than those contained herein.

LIMITED WARRANTY**

This bicycle is a quality product of STEYR-DAIMLER-PUCH A.G., Werke Graz, Austria. It has been manufactured from the finest materials and precision built with the care and know-how developed through more than ninety years of experience.

1. The Warranty. Subject to the terms, conditions and exclusions set forth below, STEYR-DAIMLER-PUCH OF AMERICA CORPORATION, (hereinafter SDPA), hereby warrants solely to the original consumer purchaser of each bicycle that the bicycle frame is free from defects in workmanship and in materials for the life of the frame and that all other parts are free from defects in workmanship and materials for one (1) year from the date of purchase by the original consumer purchaser. Any implied warranty, including any warranty of merchantability or fitness for a particular purchase, similarly extends for the life of the bicycle frame but is for all other parts limited to one (1) year from the date of purchase by the original consumer purchaser. It should be noted that some states do not allow limitation on how long an implied warranty lasts, so the above limitation may not apply.

2. Legal Rights. This warranty gives the original consumer purchaser legal rights, and he may also have other rights which vary from state to state.

3. Conditions for Warranty.

a) This warranty shall become effective only if Parts 1 and 2 of the Warranty Registration Card are completed by the original consumer purchaser and Part 2 is mailed to STEYR-DAIMLER-PUCH OF AMERICA CORPORATION, P. O. Box 7777, Greenwich, Connecticut 06830, and postmarked no later than thirty (30) days after purchase.

b) This warranty shall also become null and void.

(1) if any of the serial numbers are removed, defaced or altered; or

(2) if any unauthorized modification or alteration is made; or

(3) if any unauthorized or nonstandardized spare part is installed; or

(4) if any maintenance or repair is performed during the first year from the date of purchase by the original consumer purchaser by anyone other than SDPA or an authorized dealer.

c) The warranty shall expire upon transfer by the original consumer purchaser to a subsequent consumer purchaser.

4. Exclusions from warranty coverage. The following parts, defects, damages and losses are excluded from coverage by this warranty:

a) All items subject to normal wear and tear, including, but not limited to, brake linings, tires, tubes, springs, chains, sprockets, sheaths and cables.

b) Light bulbs, protective lenses, soft trim, decals and paint.

c) Defects resulting from misuse, abuse, negligence, use of unauthorized spare parts, and improper maintenance.
